- a. The "Vitrex System 1000" Vitreous Enamel Steel Utility School Chalk Boards have been manufactured strictly in accordance with our manufacturing details and in accordance with the relevant specifications and standards.
- b. The vitreous enamel steel finish to the Vitrex System 1000 Chalk Boards is guaranteed to perform specifically to the functions for which it was intended, and to remain functionally unchanged for a period of twenty (20) years.
- c. The conditional guarantee covers defective finish, under conditions of normal usage.
- d. The conditional guarantee is valid from the date of supply of the Vitrex System 1000 Chalk Boards.
- e. Please note the following comments and exclusions:
  - i. Fair wear and tear is excluded.
  - ii. Consequential damage is excluded.
  - iii. The application of any additional finishes to the original vitreous enamel steel surface will render the guarantee null and void.
  - iv. The fitting of any additional accessories and components as well as any subsequent alterations made to the Vitrex System 1000 Chalk Boards will render the guarantee null and void, unless the work has been undertaken in accordance with the relevant instructions and standards as confirmed by Vitrex (Pty) Ltd.
